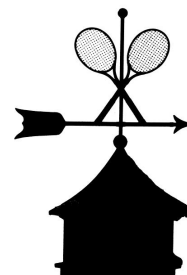

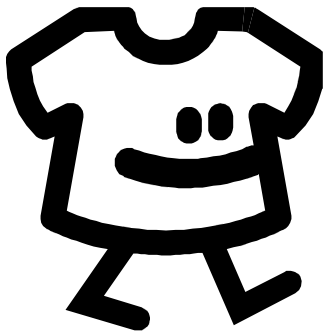

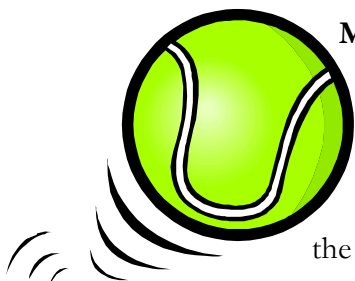

Men's and Women's Doubles Champions

The Men's and Women's Doubles Championships took place on August 28, 2010. The Women's field had four teams competing. In the final, **Kate Morneau** and **Asa Nilsson** took on **Barbara Beaudoin** and **Stacie Mancuso**. It appeared that Beaudoin and Mancuso were nervous facing the first-seeded Morneau and Nilsson, as the number-one-seeded Morneau and Nilsson easily took the first set 6-0. However, Beaudoin and Mancuso quickly turned things around in the second set and calmed their nerves. The second set was very competitive, but Morneau and Nilsson eventually pulled out a 6-0, 6-4 victory to take home the title.

The Men's field had eight teams. The competition was fierce with many close matches. In the semi-finals, the last minute team of **Jeff Morneau** and Club President **David Appleman** took on **Per Nilsson** and **Alex Guardia**. The highly anticipated semi-final match gave the viewing public everything they wanted and more. Paddlemania

Contract Request Guidelines

The deadline for submitting paddle contract requests is October 15. Contract time begins the week of November 1. In an effort to set forth guidelines for contract time, the Paddle Committee has established the following rules:

1. Time slot priority will be given to those same groups who previously had the same time slot the year before.
2. All contract time requests must be filed by the deadline or you will lose your time slot.
3. All contract times will require a minimum of six players per court.
4. Contract time requests must include a list of names of players, phone numbers and e-mail addresses.
5. We reserve the right to limit the contract time of some members who are already slotted to play two times (i.e. if they are slotted for a third time it cannot be to the detriment of other members).
6. Each contract request must provide a second choice.
7. If necessary, we will split the season (i.e. November - January/February - April), unless parties agree to split the contract time. — *Dave Appleman*
